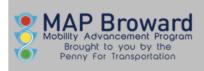
Summary – Sheridan Street Expansion



- In FY2021, the Oversight Board approved expenditures associated with a proposed expansion project on Sheridan Street
- This project encompasses program goals of: relieving traffic congestion;
 expanding the availability of multimodal options, and; creating connectivity
- The expansion project's location is also a jurisdictional boundary for Pembroke Pines to the south and Southwest Ranches to the north; affecting Town of Davie
- The project is intended to be delivered using a Design-Build method
- Solicitation process (Step 1) for the project began in 2022; Step 2 for the solicitation process occurred in 2023
- Selection Committee met in June

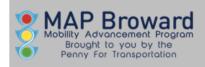
Low-Bid Tracks Price Escalation Rates







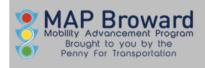

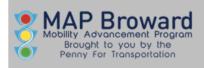
Municipal Capital Project (MCP) Conversion Request



- 2nd Amendment to the Global Interlocal Agreement (ILA) includes process for phase conversion requests for MCPs.
- During Cycle 3, the MPO reviewed, ranked and recommended new MCP project OAKL-22-004 as a design-phase project, and recommend funding in the amount of \$471,137 for FY2027.
- After review by the Oversight Board and Board of County Commissioners in 2022, funding for this project was programmed in the Five-Year plan for FY2027.
- The City reached out to MAP Admin in January 2023, requesting:
 - 1. To convert the project from design to construction; and
 - 2. To advance project in the Five-Year Plan from FY2027 to FY2025.

Transportation Surtax Program Overview




- The transportation sales surtax is authorized to be levied by Charter Counties (like Broward) under Sec. 212.055, Florida Statutes. Broward County's sales surtax began generating revenues January 1, 2019.
- The MAP Broward surtax program is budgeted on the County's fiscal year which runs from October 1 to September 30, annually.
- We are in the last quarter of fiscal year (FY) 2023 and budgeting for FY 2024.
- The Oversight Board is reviewing and approving the statutory eligibility of proposed projects and expenditures in the surtax capital fund for FY2024, as well as the proposed Five-Year Plans (FY2024-2028) prior to the County Commission approving the budget.
- The County Commission will have a Budget Workshop including the Surtax program
 August 29th, 2023; followed by two public hearings in September before adopting
 its FY2024 budget.



An updated project ID and status updates will be provided to the Oversight Board at a future meeting.



Entire Fixed-Route Fleet Electrified by FY2035

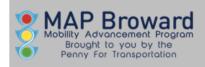

Major Program Accomplishments







Pembroke Rd/Miramar Pkwy Expansion Project -<u>largest municipal surtax</u> <u>project by value</u> in the program to date!

- > Over 300 roadway and transit infrastructure projects completed in just 4 years
- > 57 projects so far with County Business Enterprise (CBE) small business goals assigned are expected create = \$373M in business revenue and over 2,300 jobs*
- > \$5M Safe Streets and Roads for All Grant (USDOT/FHWA) discretionary planning grant using \$1.25M of surtax and County in-kind resources as the required match
- > Transportation system enhancements: community shuttle, commuter rail, PREMO study, and transit pilots are funded with surtax (in-whole or in-part)
- ➤ Countywide innovative signal system investments are heavily programmed into the first 10 years of the program to ensure backbone exists for implementing impactful congestion management strategies
- > \$1B of surtax funding has been appropriated for County projects
 - Transit, Public Works, Support Services, and transfers to FDOT
- ➤ Significant progress (\$152M) toward 30-year non-surtax funding leverage goal of \$2.5B

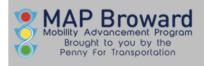
Municipal Surtax Grantee Scorecard



- Annually, MAP Administration provides the MPO with a Municipal Scorecard, to be utilized as a secondary criteria for their ranking and evaluation of new Municipal Capital Projects (MCPs)
- Each Municipality is scored based on:
 - Criteria defined in the 2nd Amendment to the Interlocal Agreement: Schedule, Budget, Delivery Goals, and CBE
 - Ratio of projects under agreement to total awarded projects
 - Reporting compliance (for projects under agreement)
- Each municipality starts with an automatic score of 8 and can get up to a maximum of 10 points depending on performance







Proposed Surtax Investments 2024 Geographical Analysis





Surtax Investments by Municipality, Life-to-date





Proposed Surtax Investments by ZIP Code - FY 2024










- The Office has also requested a 5% increase for existing Surtax Legal positions





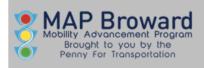

MAP Administration – FY 2024 Update




There are 14 positions directly budgeted in the Surtax Fund under Mobility Advancement Program Administration. There are 3 positions budgeted within the Surtax Fund under the Office of Economic and Small Business Development and 3 positions in Public Works. There are 4 positions budgeted within County Attorney and 1 within County Auditor in the general fund that are reimbursed by the Surtax Fund. Recurring operating expenses are budgeted in the five-year program to support these positions as well as support for Broward Metropolitan Planning Organization activities related to surtax.
